#### Little Mule Creek Prescribed Burn Association

Prescribed burn associations (PBA) have been around the Great Plains now for a couple of decades. And, the concept continues to grow. Just recently a new association formed in Barber County called the Little Mule Creek Prescribed Burn Association. Although PBAs do not have official geographical boundaries, it roughly covers the area south of Highway 160 and east of the Gyp Hills Road in Barber County.

The Little Mule Creek PBA was officially formed in February and held their first annual meeting on February 27<sup>th</sup>. The Chairman is Allan Maze and the Secretary/Treasurer is Eva Yearout. Other directors include John Cook, Matt Cantrell, Jim Sheetz and Colby Houlton.

The Little Mule Creek PBA grew out of the realization by local ranchers that they need to get more fire on the land in order to combat the uncheck spread of Eastern Red Cedars. These native invasive trees are reducing the carrying capacity of the rangelands by taking up space, reducing the nutrients and water availability for grasses and forbs.


The most efficient method of controlling the Eastern Red Cedars and preserving the native grass ecosystem is by burning the area. Native grasslands have evolved throughout time with fire being a natural and necessary part of their development and existence.

The future of grasslands in the Great Plains lies in "neighbors helping neighbors" to implement prescription burn plans. The complexities of using fire as a resource management tool are many. The value of having adequate numbers of helpers, pieces of equipment and people with training and experience cannot be over emphasized. These tools can only be organized effectively through the formation of prescribed burn associations which have the motto of "neighbor helping neighbor".

By reducing the equipment and labor costs as well as risk and legal liability concerns of applying prescribed fire on private land, PBAs have proven to be a valuable tool for encouraging landowners to apply fire across the landscape to reduce woody plants such as Eastern Red Cedar. At the end of the day, in rangelands, it is generally not a question of will the grasslands burn, but when will they burn and how much (or little) control over the fire will managers have when fire occurs. Prescribed burning is a far better alternative than the recent wildfires.

### April is State Cost Share Sign-Up

Applications are now being accepted and throughout the month of April for cost share assistance through the state's Water Resources Cost Share Program (WRCSP) and the Non-Point Source Pollution Control Program (NPS). A few of the practices which are available through these two programs are erosion control structures, pipe outlet terraces, construction of terraces and grassed waterways, range and pasture seeding, livestock water developments (to include tanks, wells, pumping systems, and pipelines), fencing, and dry hydrants for rural fire protection. Also included in the NPS program specifically are abandoned water well plugging and repair of failed septic systems.

All applications will be ranked according to a priority based ranking worksheet, and funded corresponding to their ranking until all funds are allocated. Projects cannot be started prior to contract approval by the state. To apply for these funds, call or stop by the conservation office and let us know about your project needs.

## Range Youth Camp Scholarship



Range Youth Camp is the most accepted and enduring activity of the Kansas Section of the Society for Range Management. The camp was first held in 1960 and is continuing to educate youth about the importance of Kansas rangelands to this day. The camp is designed to give students a basic understanding of the principles of rangeland ecology, including plant physiology, plant identification, ecological sites, range condition, and trend. Additional topics discussed at camp are animal behavior, animal nutrition, wildlife use of rangelands, and calculating stocking rates.

Upcoming High School Sophomore, Junior, and Senior students who have a serious interest in rangeland management, rangeland ecology, or grazing animals are eligible for a scholarship through the Barber County Conservation District to attend the camp June 23-26, 2020 at Camp Mennoscah in Murdock, KS. # <u>BULLETIN</u>: USDA Service Centers Encourage Visitors to Make Appointments in Advance As issued by USDA FSA 3/18/2020 Due to Recent Public Health Concerns

US Department of Agriculture service centers are encouraging visitors to take proactive protective measures to help prevent the spread of new coronavirus. All service center visitors wishing to conduct business with the Farms Service Agency, Natural Resources Conservation Service or any other service center agency (i.e. Conservation District) should call service centers and make appointments before visiting.

Please ask yourself these three questions before visiting a service center:

- Have you, someone living in your household, someone you have been in close or frequent contact with, or someone you are caring for been diagnosed with COVID-19 (new Coronavirus) or had any contact with a confirmed case of COVID-19?
- In the last 14 days, have you or someone living in your household, or someone you have been in close or frequent contact with, or someone you are caring for returned from, or made a travel connection through a CDC Level 3 or Level 2 country or State Department Level 3 or Level 4 country?
- Do you currently have, or have you had within the last 24 hours, any cold or flu symptoms with a fever greater than 100.4 or acute respiratory distress (e.g.shortness of breath and coughing).

If you answered "yes" to any of these questions, you must contact your local service center to make an appointment by phone. If you answer "no" to all of the above questions, you may visit the service center as normal. Please call before visiting to ensure your office is open and make an appointment. You will be asked these screening questions upon your arrival at the office.

If preferred, customers may contact their local service center to make arrangements to complete necessary paperwork by alternative means, such as over the phone, electronically, or by mail. Find your service center's phone number at farmers.gov/service-center-locator.

Additional online services are available to customers with an eAuth account, which provides access to the farmers.gov portal including viewing USDA program applications and payments. Customers who do not already have an eAuth account can enroll at farmers.gov/sign-in.
